## ZONING PERMITS

Permit fees include the required \$15 recording fee, unless otherwise stated. If applying for more than one permit type on an application, the higher fee applies. An expedited zoning permit application review to be completed within 5 business days from submission is available for a \$75 surcharge. All zoning permits require a Certificate of Compliance/Occupancy.

## DEVELOPMENT REVIEW

*If multiple development review application types can be heard at the same hearing, the applicant is eligible for a 50% discount off the least expensive review. Application fees include the required \$15 recording fee (except for sketch) and \$85 warning fee (except for sketch and site plans). Except for sketch plan & administrative amendment applications, all applications are subject to an additional \$2 notice fee per adjoining property owner and application party. Development review decisions often require an applicant to obtain a zoning permit. Some decisions may require the applicant to establish an escrow for legal and/or technical review. If additional warned hearings are required, additional recording, warning and abutters fees apply.*
